

Terms and Conditions of Participation

Terms and Conditions of Participation in the AniCura Medical Congress 2025

§1. General Provisions

- 1.1. The organizer of the event titled AniCura Medical Congress, taking place on June 6–7, 2025 in Kraków, is AniCura Poland sp. z o.o., with its registered office in Warsaw, ul. Grzybowska 29, 00-131 Warsaw, hereinafter referred to as the "Organizer".
- 1.2. The Congress is an in-person event addressed exclusively to veterinarians and individuals associated with the veterinary industry.
- 1.3. The purpose of the Congress is to promote knowledge, exchange experiences, and integrate the veterinary community.
- 1.4. These Terms and Conditions define the rules of participation in the Veterinary Congress organized by AniCura (hereinafter: "Organizer").

§2. Registration and Participation

- 2.1. Participation in the Congress requires registration via the form available at:

- 2.2. The number of available spots is limited. Participation is granted on a first-come, first-served basis and depends on the date of payment confirmation.
- 2.3. Applications will be accepted until all available spots are filled.
- 2.4. During registration, the Participant must provide: name, surname, email address, phone number, and company information (if applicable).
- 2.5. Registration is binding upon payment.

§3. Participation Fee

- 3.1. The participation fee for the Congress is PLN 750 net + 23% VAT (PLN 921.50 gross).
- 3.2. The fee includes:
 - participation in lectures and panels on June 6–7, 2025,
 - lunch and coffee breaks on both days,
 - dinner, Gala Dinner and afterparty,
 - transfer to the Gala from Double Tree by Hilton hotel,
 - access to the sponsors' and exhibitors' zone.
- 3.3. The fee does not include: accommodation, breakfasts, or transportation to the event venue.
- 3.4. The participation fee must be paid via bank transfer to the account specified by the Organizer in the registration confirmation email.

3.5. A VAT invoice will be issued after the payment is credited, using the company details provided in the registration form, and sent to the email address provided during registration.

3.6. Failure to make payment within 3 days of registration will be considered a withdrawal from participation.

§4. Withdrawal from Participation

4.1. A Participant may withdraw from the Congress, however:

- in case of cancellation less than 40 days before the event (i.e., after April 26, 2025), the fee is non-refundable,
- in case of cancellation more than 30 days before the event, the Organizer may refund the full amount paid.

§5. Data and Image Processing

5.1. Participants consent to the processing of their personal data in accordance with the applicable GDPR regulations for the purpose of organizing and conducting the Congress.

5.2. Participants may be asked to sign a separate consent for the use of their image (including photos and video recordings) for promotional and informational purposes by the Organizer and entities of the Mars Petcare group.

5.3. The privacy policy and GDPR-related information are included in a separate file attached to the registration form. By registering, Participants confirm that they have read these documents.

§6. Cancellation and Changes

6.1. The Organizer reserves the right to cancel the Congress or change its date due to reasons beyond its control.

6.2. In case of cancellation, the Participant is entitled to a refund.

§7. Final Provisions

7.1. The Organizer reserves the right to make changes to the Congress program due to important organizational reasons or reasons beyond its control.

7.2. Participation in the Congress implies acceptance of these Terms and Conditions.

7.3. Matters not regulated by these Terms and Conditions shall be governed by the relevant provisions of Polish law.
